

AN ACT MAKING AN APPROPRIATION TO IMPLEMENT
THE INTENT OF PUBLIC LAW 11-146, ELEVENTH
GUAM LEGISLATURE, RELATIVE TO THE PAYMENT OF
BONUSES TO VETERANS OF THE ARMED FORCES OF
THE UNITED STATES WHO SERVED IN ACTIVE DUTY
DURING THE WORLD WAR II, KOREAN WAR OR THE
INDO-CHINA CONFLICT, AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 balance in the Unappropriated Surplus of the General Fund the
4 sum of ^{zero} ~~Two Hundred Thirty-Five Thousand Dollars (\$235,000)~~ ⁻⁰⁻ to
5 implement the intent of Public Law 11-146, Eleventh Guam
6 Legislature, for payment of bonuses to persons entitled as
7 prescribed by Section 8981 of the Government Code of Guam.

8 Section 2. There is hereby appropriated from any available
9 balance in the Unappropriated Surplus of the General Fund the
10 sum of Ten Thousand Dollars (\$10,000) to defray the cost of
11 relocating portable classrooms.

12 Section 3. There is hereby appropriated from any available
13 balance in the Unappropriated Surplus of the General Fund the

1 sum of One Thousand Five Hundred Dollars (\$1,500) to provide for
2 street lighting facilities in the Hyundai Subdivision in
3 Mongmong.

4 Section 4. There is hereby appropriated from any available
5 balance in the Unappropriated Surplus of the General Fund the
6 sum of Five Thousand Dollars (\$5,000) to provide for a canopy at
7 the P. C. Lujan Elementary School in Barrigada.

8 Section 5. There is hereby appropriated from any available
9 balance in the Unappropriated Surplus of the General Fund the
10 the sum of Five Thousand Dollars (\$5,000) for street lighting
11 facilities in Mangilao.

12 Section 6. There is hereby appropriated from any available
13 balance in the Unappropriated Surplus of the General Fund the
14 sum of Fifteen Thousand Dollars (\$15,000) for the purpose of
15 extending water and power facilities to residents in the northern
16 portion of the village of Umatac.

17 Section 7. There is hereby appropriated from any available
18 balance in the Unappropriated Surplus of the General Fund the
19 sum of Ten Thousand Dollars (\$10,000) to provide for the
20 installation of fire hydrants in the Paasan area in Agana
21 Heights.

22 Section 8. There is hereby appropriated from any available
23 balance in the Unappropriated Surplus of the General Fund the
24 sum of Thirty-Five Thousand Dollars (\$35,000) to provide for
25 the extension of a waterline in the Agafu Gumas Subdivision in
26 Yigo.

27 Section 9. There is hereby appropriated from any available
28 balance in the Unappropriated Surplus of the General Fund the
29 sum of Five Thousand Dollars (\$5,000) to provide for the
30 extension of a waterline in the Y-Nasso area in Agat.

31 Section 10. There is hereby appropriated from any available

1 balance in the Unappropriated Surplus of the General Fund the
2 sum of ^{zero} ~~Fifteen Thousand Dollars (\$15,000)~~ ⁻⁰⁻ to supplement the
3 appropriation made by Section 2 of Public Law 11-89 for
4 the Washington Delegation on Federal Problems for the purpose
5 of providing the delegation with such assistance as may be
6 necessary for the presentation in Washington, D. C. relating
7 to land claims of the people of Guam and other Federal matters.
