AN ACT MAKING AN APPROPRIATION TO IMPLEMENT THE INTENT OF PUBLIC LAW 11-146, ELEVENTH GUAM LEGISLATURE, RELATIVE TO THE PAYMENT OF BONUSES TO VETERANS OF THE ARMED FORCES OF THE UNITED STATES WHO SERVED IN ACTIVE DUTY DURING THE WORLD WAR II, KOREAN WAR OR THE INDO-CHINA CONFLICT, AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM: Section 1. There is hereby appropriated from any available balance in the Unappropriated Surplus of the General Fund the zero -0sum of Two-Hundred Thirty=Five Thousand-Dollars (\$235,000) to implement the intent of Public Law 11-146, Eleventh Guam Legislature, for payment of bonuses to persons entitled as prescribed by Section 8981 of the Government Code of Guam.

Section 2. There is hereby appropriated from any available balance in the Unappropriated Surplus of the General Fund the sum of Ten Thousand Dollars (\$10,000) to defray the cost of relocating portable classrooms.

Section 3. There is hereby appropriated from any available balance in the Unappropriated Surplus of the General Fund the

sum of One Thousand Five Hundred Dollars (\$1,500) to provide for street lighting facilities in the Hyundai Subdivision in Mongmong.

Section 4. There is hereby appropriated from any available balance in the Unappropriated Surplus of the General Fund the sum of Five Thousand Dollars (\$5,000) to provide for a canopy at the P. C. Lujan Elementary School in Barrigada.

Section 5. There is hereby appropriated from any available balance in the Unappropriated Surplus of the General Fund the the sum of Five Thousand Dollars (\$5,000) for street lighting facilities in Mangilao.

Section 6. There is hereby appropriated from any available balance in the Unappropriated Surplus of the General Fund the sum of Fifteen Thousand Dollars (\$15,000) for the purpose of extending water and power facilities to residents in the northern portion of the village of Umatac.

Section 7. There is hereby appropriated from any available balance in the Unappropriated Surplus of the General Fund the sum of Ten Thousand Dollars (\$10,000) to provide for the installation of fire hydrants in the Paasan area in Agana Heights.

Section 8. There is hereby appropriated from any available balance in the Unappropriated Surplus of the General Fund the sum of Thirty-Five Thousand Dollars (\$35,000) to provide for the extension of a waterline in the Agafu Gumas Subdivision in Yigo.

Section 9. There is hereby appropriated from any available balance in the Unappropriated Surplus of the General Fund the sum of Five Thousand Dollars (\$5,000) to provide for the extension of a waterline in the Y-Nasso area in Agat.
