

AN ACT MAKING APPROPRIATIONS FOR THE
OPERATION OF THE REGIONAL COMMITTEE
MEETING OF THE WORLD HEALTH ORGANIZATION
BEING HOSTED BY GUAM UNDER THE AUSPICES
OF THE DEPARTMENT OF PUBLIC HEALTH AND
SOCIAL SERVICES, AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 funds in the Unappropriated Surplus of the General Fund the sum
4 of Fifty Thousand Dollars (\$50,000) for the operation of the
5 Regional Committee Meeting of the World Health Organization
6 being hosted by Guam.

7 Section 2. There is hereby appropriated from any available
8 funds in the Unappropriated Surplus of the General Fund the sum
9 of ^{Zero} ~~Twenty-Five-Thousand-Dollars~~ ⁽⁰⁾ ~~(\$25,000)~~ to the Pacific
10 Conference of Legislators.

11 Section 3. There is hereby appropriated from any available
12 funds in the Unappropriated Surplus of the General Fund the sum
13 of Thirty-One Thousand Five Hundred Dollars (\$31,500) for the
14 extension of a sewer line along Route 8 in Maite in the
15 municipality of Mongmong-Toto-Maite.

16 Section 4. There is hereby appropriated from any available
17 funds in the Unappropriated Surplus of the General Fund the sum
18 of Two Thousand Five Hundred Dollars (\$2,500) for temporary
19 lights at all wakes when requested.

20 Section 5. There is hereby appropriated from any available
21 funds in the Unappropriated Surplus of the General Fund the sum
22 of One Hundred Thousand Dollars (\$100,000) for the installation
23 of a waterline commencing from U.S. Navy High Pressure Line to

1 Lot Nos. 401-R-2 and 402-10-11, and the construction of a
2 reservoir in the municipality of Agat.

3 Section 6. There is hereby appropriated from any available
4 funds in the Unappropriated Surplus of the General Fund the sum
5 of Five Thousand Dollars (\$5,000) for the architectural and
6 engineering designs, plans and specifications for the Mongmong-
7 Toto-Maite Recreational Center.

8 Section 7. There is hereby appropriated from any available
9 funds in the Unappropriated Surplus of the General Fund the sum
10 of Ten Thousand Dollars (\$10,000) for the construction of
11 canopies on sidewalks between the buildings at the University
12 of Guam.
