AN ACT MAKING AN APPROPRIATION PURSUANT TO PUBLIC LAW 11-105, ELEVENTH GUAM LEGIS-LATURE, FOR THE CONSTRUCTION OF AN ADDITION TO THE CENTRAL PUBLIC HEALTH AND SOCIAL SERVICES DIAGNOSTIC AND TREATMENT CENTER IN MANGILAO, AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of One Hundred and Eighty Thousand Dollars (\$180,000.00) to provide for the construction of an addition to the Central Public Health and Social Services Diagnostic and Treatment Center in Mangilao pursuant to Public Law 11-105, Eleventh Guam Legislature.

Section 2. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Forty-Two Thousand Dollars (\$42,000.00) to supplement the appropriations made by Public Law 11-8, Eleventh Guam Legislature, and Section 2 of Public Law 11-108, Eleventh Guam Legislature, for the construction of a public library building in the village of Merizo.

Section 3. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Two Thousand Dollars (\$2,000.00) to provide for the extension of power to the Cruz Subdivision in the municipality of Agat.

Section 4. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Five Thousand Dollars (\$5,000.00) to construct additional bus shelters in the various districts throughout Guam.

Section 5. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Eight Thousand Dollars (\$8,000.00) for the installation of street lights along Marine Drive in Anigua.

Section 6. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of One Hundred Four Thousand Dollars (\$104,000.00) for the payment of claims against the government.

Section 7. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Seven Thousand Five Hundred Dollars (\$7,500.00) for the installation of street lights alongside that portion of Route 16, commencing at the junction of Route 16 and Route 8 in Barrigada and extending to the entrance of the Harmon Strip.

Section 8. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Three Thousand Dollars (\$3,000:00) for the installation of street lights along Marine Drive between Wettengel Junction and the Layne International Building and along Santa-Monica Avenue from Marine Drive to the Wettengel School in the municipality of Dededo and in the municipality of Yigo 2 3 2000.

Section 9. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Four Thousand Dollars (\$4,000.00) for the installation of twenty-seven (27) additional street lights in the municipality of Talofofo.

Section 10. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Three Thousand Dollars (\$3,000.00) for the installation of additional street lights in San Antonio-Lalo, Leyang, Aspengao, Canada and Toto areas in the municipality of Barrigada.

Section 11. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Ten Thousand Dollars (\$10,000.00) for the construction of launching ramps for small boats to be located at the former Old Agat Elementary School site behind the latte stone sign post installed by the Chamber of Commerce, such launching ramps to be available for the joint use of the villages of Agat and Santa Rita.

Section 12. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum Zero (0) of Twenty-Five-Theusand-Dollars-(\$25,000-00) to the Pacific Conference of Legislators to pay for outstanding accounts payable by the Pacific Conference of Legislators.

Section 13. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Eight Thousand Dollars (\$8,000.00) to pay the outstanding printing accounts of the Constitutional Convention.

Section 14. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Twenty-Five Thousand Dollars (\$25,000.00) for the construction of a Commissioner's Office in Mongmong.
