

AN ACT MAKING AN APPROPRIATION FOR THE  
OPERATION OF THE DEPARTMENT OF LABOR FOR  
THE SECOND QUARTER OF THE FISCAL YEAR  
ENDING JUNE 30, 1973, AND FOR OTHER  
PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available  
3 funds in the Unappropriated Surplus of the General Fund the  
4 following sums for the operation of the Department of Labor  
5 for the second three (3) months (October 1, 1972 through  
6 December 31, 1972) of the fiscal year ending June 30, 1973:

7 A. Department of Labor

Section 3. Paragraph L of Section 1 of Public Law 11-154  
is hereby amended to read as follows:

"L. Territorial Planning Commission

1. Personnel Services	\$80,968
2. Off-Island Travel and Transportation	6,000
3. Local Travel, Contractual Services, Supplies and Materials Equipment and Miscellaneous Items	18,288"

Section 4. The Governor is hereby authorized to transfer  
an aggregate of not to exceed five per cent (5%) of any item  
of appropriation made for the operation of the Department of  
Labor by Section 1 of this Act to any other item of appropriation  
made for the operation of the department; provided however that  
no item of appropriation shall be increased an aggregate of  
more than five per cent (5%).
