

CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR



AN ACT TO AMEND SECTION 4103 OF THE  
GOVERNMENT CODE OF GUAM TO INCREASE  
THE RATE OF PAY SET FORTH IN THE PAY  
RANGE SCHEDULE AND AUTHORIZE AN APPRO-  
PRIATION THEREFOR.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. The pay range schedule set forth in Section 4103  
3 of the Government Code of Guam is hereby amended by adding the  
4 figure "312" to each step and each pay range.

5 Section 2. There is hereby authorized to be appropriated  
6 such sums as may be necessary to carry out the purposes set  
7 forth in Section 1 of this Act.

8 Section 3. This Act shall take effect, July 1, 1973.
