


CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR






AN ACT TO ESTABLISH A PRIORITY FOR THE  
REMAINING UNSOLD LOTS IN THE GOVERNMENT  
OF GUAM BARRIGADA HEIGHTS SUBDIVISION.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Notwithstanding any provision of law to the  
3 contrary, the Land Transfer Board and the Director of Land  
4 Management, in considering and acting upon applications to lease  
5 or buy government real property located in the Barrigada Heights  
6 Subdivision, Tract 9, portions of lots 5218, 5219 and 5382, Land  
7 Management Drawing Number E4-53T210, shall apply and observe the  
8 following priority:

9 First preference shall be given to those persons,  
10 their executors or administrators, who were former residents  
11 of that area known as Radio Barrigada, who were evicted  
12 from said land as a result of the taking of such land  
13 for public uses by the Federal government, and who are  
14 without fee title to any real property of their own upon  
15 which decent safe and sanitary housing can be erected. In  
16 the event that the number of persons entitled to  
17 first preference under the provisions of this Act  
18 exceeds the number of available lots in said subdivision,  
19 then in that event their priority shall be determined by  
20 the filing date on his or her application for a lot in  
21 said subdivision.

22 Section 2. Notwithstanding any provision of law to the  
23 contrary, the Director of Land Management may not exchange any  
24 government real property located in the Barrigada Heights  
25 Subdivision, Tract 9, portions of lots 5218, 5219 and 5382,  
26 Land Management Drawing Number E4-53T210.
