



CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR





AN ACT MAKING AN APPROPRIATION FOR THE  
CONSTRUCTION OF BASKETBALL COURTS AT  
EAST KAISER, DEDEDO AND FOR OTHER  
PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available  
3 funds in the Unappropriated Surplus of the General Fund the  
4 sum of Twenty-Four Thousand Dollars (\$24,000) to construct  
5 two basketball courts complete with lighting facilities in  
6 the East Kaiser housing area, Dededo.

7 Section 2. There is hereby appropriated from any available  
8 funds in the Unappropriated Surplus of the General Fund the  
9 sum of Twenty-Six Thousand Three Hundred Eleven Dollars  
10 (\$26,311.00) for the operation of the Community Action Agency  
11 for a period of one (1) month.
