AN ACT MAKING AN APPROPRIATION FOR THE OPERATION OF THE DEPARTMENT OF LABOR FOR THE LAST SIX MONTHS OF THE FISCAL YEAR ENDING JUNE 30, 1973 AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the following sums for the operation of the Department of Labor for the last six (6) months (January 1, 1973 through June 30, 1973) of the fiscal year ending June 30, 1973:

Labor by Section 1 of this Act to any other item of appropriation made for the operation of the department; provided however that no item of appropriation shall be increased an aggregate of more than five per cent (5%).
