AN ACT MAKING APPROPRIATIONS FOR THE
PAVING OF THE ROAD IN SANTA RITA LEADING
FROM SANTA ROSA SUBDIVISION TO THE HARRY
S TRUMAN ELEMENTARY SCHOOL AND FOR THE
OPERATION OF THE TWELFTH GUAM LEGISLATURE
FOR THE PERIOD ENDING FEBRUARY 28, 1973.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 funds in the Unappropriated Surplus of the Territorial
4 Highway Fund the sum of ^{Zero} ~~Fifty-five Thousand Dollars (\$55,000.00)~~ (0)
5 for the paving with asphaltic concrete of the road in Santa
6 Rita leading from Santa Rosa Subdivision to the Harry S Truman
7 Elementary School.

Pl. 12-37 Section 2. There is hereby appropriated from any available
9 funds in the Unappropriated Surplus of the General Fund the
10 sum of One Hundred Thousand Dollars (\$100,000.00) for the
11 operation of the Legislature for the period ending February
12 28, 1973.

13 Section 3. The appropriation made by Section 1 of this
14 Act shall be effective immediately and shall be available
15 for all expenses incident to the purpose for which made. The
16 appropriation made herein shall continue in full force and
17 effect and shall be available until expended for the project
18 for which the appropriation is made or until the project
19 is completed.
