

CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR





AN ACT MAKING AN APPROPRIATION FOR THE  
CONSTRUCTION OF NORTH STREET IN THE  
MUNICIPALITY OF ASAN, AND FOR OTHER  
PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available  
3 funds in the Unappropriated Surplus of the Territorial Highway  
4 Fund the sum of <sup>zero (0)</sup> ~~Ten Thousand Dollars (\$10,000)~~ for the  
5 construction of North Street in the municipality of Asan.

6 Section 2. The appropriation made by Section 1 of this  
7 Act shall be made available for all expenses incident to the  
8 purpose for which made and shall continue in full force and  
9 effect until expended for the project for which made or  
10 until the project is completed.

11 Section 3. There is hereby appropriated from any available  
12 funds in the Unappropriated Surplus of the General Fund the  
13 sum of Ten Thousand Five Hundred Dollars (\$10,500) for the  
14 operation of Youth Day 1973.

15 Section 4. All proceeds collected from activities during  
16 Youth Day 1973 may be expended for the operation of Youth  
17 Day 1973.

18 Section 5. The Central Planning Committee of Youth Day  
19 1973 shall submit to the Guam Legislature and the Governor

1 of Guam a full report of the Youth Day activities including,  
2 a detailed analysis of all incomes received and expenditures  
3 made for the operation of Youth Day 1973, on or before June 1,  
4 1973.

5 Section 6. There is hereby appropriated from any available  
6 funds in the Unappropriated Surplus of the General Fund the  
7 sum of Twenty-Eight Thousand Two Hundred Dollars (\$28,200.00)  
8 for the improvement of the Department of Corrections facilities;  
9 provided, however, that the sum of Fourteen Thousand One  
10 Hundred Dollars (\$14,100.00) is provided by the United States  
11 Government.
