Introduced by P. J. Bordallo

AN ACT MAKING APPROPRIATIONS TO THE
FARMER'S SMALL LOAN REVOLVING FUND, TO
THE LEGISLATURE OPERATIONS FUND FOR THE
SPEAKER'S CONTINGENCY FUND, THE AUDITS
OF THE ACCOUNTS AND FINANCIAL TRANSACTIONS
OF THE GOVERNMENT OF GUAM, FOR OFFICE
IMPROVEMENTS AND RENOVATIONS AT THE
GUAM CONGRESS BUILDING AND FOR THE SELECT
COMMITTEE ON SPORTS WAGERING, AND TO
SUPPLEMENT THE APPROPRIATION MADE BY
PUBLIC LAW 11-212.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 funds in the Unappropriated Surplus of the General Fund the
4 sum of One Hundred Thousand Dollars (\$100,000) to the Farmer's
5 Small Loan Revolving Fund.

6 Section 2. There is hereby appropriated from any available
7 funds in the Unappropriated Surplus of the General Fund the
8 sum of Twenty Thousand Dollars (\$20,000) to the Legislature
9 Operations Fund established by Public Law 12-22 for the
10 Speaker's Contingency Fund, none of which shall be committed,
11 obligated, expended or disbursed without the approval of the
12 Speaker of the Twelfth Guam Legislature.

13 Section 3. There is hereby appropriated from any available
14 funds in the Unappropriated Surplus of the General Fund the
15 sum of Two Hundred One Thousand Ninety-Six Dollars (\$201,096)
16 to the Legislature Operations Fund for the legislative audits
17 of the accounts and financial transactions of the government
18 of Guam.

19 Section 4. There is hereby appropriated from any available
20 funds in the Unappropriated Surplus of the General Fund the
21 sum of Eighty Thousnad Dollars (\$80,000) to the Legislature

1 Operations Fund established by Public Law 12-22 for office
2 improvements and renovations at the Guam Congress Building in
3 Agana.

4 Section 5. There is hereby appropriated from any available
5 funds in the Unappropriated Surplus of the General Fund the
6 sum of Twenty-Three Thousand Dollars (\$23,000) to supplement
7 the appropriation made under Public Law 11-212, Eleventh
8 Guam Legislature.

9 Section 6. There is hereby appropriated from any available
10 funds in the Unappropriated Surplus of the General Fund the
11 sum of ~~Ten Thousand Dollars (\$10,000)~~ ^{ZERO (0) *DN*} to the Legislature
12 Operations Fund for the Select Committee on Sports Wagering,
13 none of which shall be committed, obligated, expended or
14 disbursed without the approval of the Speaker of the Twelfth
15 Guam Legislature.
