CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR

This is to certify that Bill No. 409, "An Act making an appropriation for lump sum payment of accrued annual leave to legislative employees terminated as a result of the Governor's veto of the Legislature's budget; and to repeal Sections 3 and 4 of Public Law 12-22; and to reenact Section 4 of Public Law 11-220 and Section 2 of Public Law 12-2, Twelfth Guam Legislature, and to repeal Section 2 of Public Law 12-2 to provide that all encumbrances and expenditures for the operation of the Twelfth Guam Legislature charged against appropriations made by Section 4 of Public Law 11-220 and Section 2 of Public Law 12-2 are hereby transferred and shall be charged against the appropriation made by Section 1 of Public Law 12-22, Twelfth Guam Legislature, and for other purposes", was on the 25th day of June, 1973, duly and regularly passed.

AN ACT MAKING AN APPROPRIATION FOR LUMP
SUM PAYMENT OF ACCRUED ANNUAL LEAVE TO
LEGISLATIVE EMPLOYEES TERMINATED AS A
RESULT OF THE GOVERNOR'S VETO OF THE
LEGISLATURE'S BUDGET; AND TO REPEAL
SECTIONS 3 AND 4 OF PUBLIC LAW 12-22;
AND TO REENACT SECTION 4 OF PUBLIC LAW
11-220 AND SECTION 2 OF PUBLIC LAW 12-2,
TWELFTH GUAM LEGISLATURE, AND TO REPEAL
SECTION 2 OF PUBLIC LAW 12-2 TO PROVIDE
THAT ALL ENCUMBRANCES AND EXPENDITURES
FOR THE OPERATION OF THE TWELFTH GUAM
LEGISLATURE CHARGED AGAINST APPROPRIATIONS
MADE BY SECTION 4 OF PUBLIC LAW 11-220 AND
SECTION 2 OF PUBLIC LAW 12-2 ARE HEREBY
TRANSFERRED AND SHALL BE CHARGED AGAINST
THE APPROPRIATION MADE BY SECTION 1 OF
PUBLIC LAW 12-22, TWELFTH GUAM LEGISLATURE,
AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 funds in the Unappropriated Surplus of the General Fund the
4 sum of One Hundred Thirteen Thousand Two Hundred Seven Dollars
5 (\$113,207.00) for lump sum payment of accrued annual leave to
6 employees of the Guam Legislature who were terminated as
7 a result of the Governor's veto of the Legislature's 1973
8 budget.

9 Section 2. Sections 3 and 4 of Public Law 12-22, Twelfth
10 Guam Legislature are hereby repealed and Section 4 of Public
11 Law 11-220, Eleventh Guam Legislature, and Section 2 of Public
12 Law 12-2, Twelfth Guam Legislature, are hereby reenacted.

13 Section 3. Section 2 of Public Law 12-2, Twelfth Guam
14 Legislature, is hereby repealed.

15 Section 4. All encumbrances and expenditures for the
16 operation of the Twelfth Guam Legislature charged against the
17 appropriations made by Section 4 of Public Law 11-220, Eleventh

1 Guam Legislature, and Section 2 of Public Law 12-2, Twelfth Guam
2 Legislature, are hereby transferred and shall be charged against
3 the appropriation made by Section 1 of Public Law 12-22, Twelfth
4 Guam Legislature.

5 Section 5. There is hereby appropriated from any available
6 funds in the Unappropriated Surplus of the General Fund the
7 sum of Forty-Six Thousand Six Hundred Ninety Dollars (\$46,690.00)
8 to pay for overtime night differential compensation of Department
9 of Public Safety personnel for the fiscal year ending June 30,
10 1973.

11 Section 6. There is hereby appropriated from any available
12 funds in the Unappropriated Surplus of the General Fund the
13 sum of Five Hundred Thirty-Five Thousand Nine Hundred Eighty-
14 Eight Dollars (\$535,988.00) to be transferred to the Cafeteria
15 School Lunch Fund as a subsidy of that fund for the fiscal
16 year ending June 30, 1973.

17 Section 7. There is hereby appropriated from any available
18 funds in the Unappropriated Surplus of the General Fund the
19 sum of One Hundred Seventy Thousand Dollars (\$170,000) for
20 necessary improvements to the Talofofu-Ylig Water Improvement
21 Plan, and Two Hundred Thousand Dollars (\$200,000) for necessary
22 improvements to the Inarajan-Malojloj Water Improvement System.
23 No more than fifteen per cent (15%) shall be expended for
24 planning, engineering, or architectural studies.

25 Section 8. Any unexpended sums appropriated pursuant to
26 Section 7 of this Act shall revert to the General Fund.

27 Section 9. There is hereby appropriated from any available
28 funds in the Unappropriated Surplus of the General Fund the
29 sum of Two Hundred Forty Thousand Seven Hundred Twenty Dollars
30 (\$240,720.00) to be apportioned as follows: Two Hundred Thirty-
31 Five Thousand Seven Hundred Twenty Dollars (\$235,720.00) for the
32 compensation of school bus drivers for the fiscal year ending
33 June 30, 1973 and Five Thousand Dollars (\$5,000.00) to implement
34 Resolution No. 14, Twelfth Guam Legislature.
