AN ACT MAKING AN APPROPRIATION FOR THE  
CONSTRUCTION OF A ROAD TO CONNECT THE  
KALACKAC AREA IN THE MUNICIPALITY OF ASAN  
TO THE VILLAGE PROPER, AND FOR OTHER  
PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2       Section 1. There is hereby appropriated from any available  
3 funds in the Unappropriated Surplus of the Territorial Highway  
4 Fund the sum of Twenty-Five Thousand Dollars (\$25,000) for the  
5 purpose of constructing a road to connect the Kalackac area in  
6 the municipality of Asan to the village proper of Asan.

7       Section 2. The appropriation made by Section 1 of this Act  
8 shall be made available for all expenses incident to the purpose  
9 for which made and shall continue in full force and effect until  
10 the funds are expended for the project for which made or until  
11 the project is completed.

12      Section 3. There is hereby appropriated from any available  
13 funds in the Unappropriated Surplus of the General Fund the sum  
14 of Four Thousand Dollars (\$4,000) to the Guam Recreation Commis-  
15 sion for the purpose of providing transportation for representa-  
16 tives of the local volleyball teams so as to allow them to  
17 participate in the first Oceania Volleyball Tournament to be held  
18 in Sydney, Australia.
