CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR


This is to certify that Bill No. 146, "An Act making an appropriation for the authorized overtime compensation to certain employees of the government of Guam formerly assigned to the Detention Home and its successor agency", which was heretofore passed and thereafter on November 9, 1973, returned to the Legislature without the approval of the Governor was, in accordance with the Organic Act of Guam, reconsidered by the Legislature and after such reconsideration the Legislature did on the 20th day of November, 1973, agree to pass said bill notwithstanding the objections of the Governor by a vote of more than two-thirds of all members thereof, to wit: by a vote of 17 members.

Introduced by R. F. Taitano

AN ACT MAKING AN APPROPRIATION FOR THE
AUTHORIZED OVERTIME COMPENSATION TO
CERTAIN EMPLOYEES OF THE GOVERNMENT OF
GUAM FORMERLY ASSIGNED TO THE DETENTION
HOME AND ITS SUCCESSOR AGENCY.

1 WHEREAS, it has come to the attention of this Legislature
2 that seven employees of the government of Guam assigned to the
3 Detention Home and its successor agency were authorized by their
4 supervisors to receive overtime compensation while working for
5 the Facility prior to 1968, which compensation was also autho-
6 rized by the department heads of the government of Guam but
7 never paid to these employees; and

8 WHEREAS, these employees, relying, to their detriment, on
9 the statements made by their supervisors and department heads,
10 rendered services beyond the scope of their employment; now
11 therefore

12 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

13 Section 1. There is hereby appropriated from any available
14 funds in the Unappropriated Surplus of the General Fund the sum
15 of Forty-Seven Thousand Five Hundred Ninety-Four Dollars and
16 Twenty-Three Cents (\$47,594.23) to the Juvenile Justice Division
17 of the Courts of Guam for authorized overtime compensation due
18 to seven employees of the government of Guam formerly assigned
19 to the Detention Home and its successor agency.
