



CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR



AN ACT TO AMEND SECTION 1 OF PUBLIC LAW 12-64, RELATIVE TO THE OFFICE OF THE TERRITORIAL AUDITOR AND TO AMEND SECTION 4106 OF THE GOVERNMENT CODE OF GUAM TO INCLUDE THE POSITIONS OF DEPUTY TERRITORIAL AUDITOR AND EXECUTIVE SECRETARY (OFFICE OF THE TERRITORIAL AUDITOR) WITHIN THE UNCLASSIFIED SERVICE, AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Section 1 of Public Law 12-64, Twelfth Guam  
3 Legislature, is hereby amended to read as follows:

4 "Section 1. There is hereby appropriated from any  
5 available funds in the Unappropriated Surplus of the  
6 General Fund the sum of Fifty Thousand Dollars (\$50,000)  
7 for the organizational expenses of the Office of the  
8 Territorial Auditor established by Section 6 of Public  
9 Law 12-34. Such sums shall be used for the salaries of  
10 the Territorial Auditor at the salary prescribed by law,  
11 of the Executive Secretary and of a Deputy Territorial  
12 Auditor, for the rental of appropriate office space,  
13 necessary supplies and materials, office equipment,  
14 utilities (telephone, water, power and sewer), vehicle and  
15 off-island recruitment travel and transportation."

16 Section 2. Section 4106 of the Government Code of Guam is  
17 hereby amended by adding the following:

18 "Deputy Territorial Auditor ..... 1 .....\$19,000  
19 Executive Secretary (Office of the  
20 Territorial Auditor) ..... 1 .....\$10,500"

21 Section 3. Schedule Two of Section 2, III, A of Public  
22 Law 12-62 is hereby amended to read as follows:

23 "Schedule Two - Personal Services for the Office  
24 of the Minority  
25 (Section 2, III, A)  
26 Minority Legal Services, not to exceed \$22,020."
