AN ACT MAKING AN APPROPRIATION TO PURCHASE
AGRICULTURAL EQUIPMENT FOR THE FARMERS OF
GUAM AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 funds in the Unappropriated Surplus of the General Fund the sum
4 of ~~One Hundred Twenty-one Thousand Dollars (\$121,000)~~ ^{Sixty Thousand Dollars (\$60,000)} *Cr* to the
5 Department of Agriculture for the purchase of a new bulldozer,
6 D-7, with hydraulic ripper and blade; bulldozer, D-6, with
7 hydraulic ripper and blade; farm tractors, tractor mower, disc
8 harrow, middle buster, plow and power sprayer.

9 Section 2. There is hereby appropriated from any available
10 funds in the Unappropriated Surplus of the General Fund the sum
11 of Ten Thousand Dollars (\$10,000) to the Department of Correc-
12 tions for the purchase of food.
