





AN ACT TO MAKE AN APPROPRIATION FOR
INSTALLATION OF SEWER FACILITIES IN
THE VILLAGE OF UMATAC, AND FOR OTHER
PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 funds in the Unappropriated Surplus of the General Fund the
4 sum of Five Hundred Thousand Dollars (\$500,000) for the
5 installation of sewer outfall, treatment plant, and collection
6 lines in the village of Umatac.

7 Section 2. The Director of the Bureau of Planning,
8 Budgeting and Management shall submit a progress report to the
9 Legislature no later than the fifteenth (15th) day of each
10 month, beginning with April 15, 1974, of the project authorized
11 and funded by Section 1 of this Act.

12 Section 3. The appropriation made by Section 24(3) of
13 Public Law 12-60 "for the Agat-Nimitz sewer system" is hereby
14 reduced by Five Hundred Fifteen Thousand Dollars (\$515,000).

1 Section 4. There is hereby appropriated from any available
2 funds in the Unappropriated Surplus of the General Fund the
3 sum of Five Hundred Fifteen Thousand Dollars (\$515,000) to
4 supplement the appropriation made by Section 24(3) of Public
5 Law 12-60 "for the Agat-Nimitz sewer system" provided, however,
6 that the appropriation shall be effective July 1, 1974.

7 Section 5. There is hereby appropriated from any available
8 funds in the Unappropriated Surplus of the General Fund the
9 sum of Ten Thousand Dollars (\$10,000), said sum to be transferred
10 to the Legislature Operations Fund to implement Resolution
11 No. 213.

12 Section 6. There is hereby appropriated from any available
13 funds in the Unappropriated Surplus of the General Fund the
14 sum of Five Thousand Dollars (\$5,000), said sum to be trans-
15 ferred to the Legislature Operations Fund to implement Resolution
16 No. 22 which creates the Select Committee on Sports Wagering.

17 Section 7. Section 21209 of the Government Code of Guam
18 is hereby repealed in its entirety.
