


CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR





AN ACT TO AUTHORIZE A FIVE-YEAR SMALL  
BOAT LAUNCHING RAMPS AND MARINA PROGRAM  
AND TO AUTHORIZE AN APPROPRIATION THEREFOR.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 *amended PL 13-49*  
Section 1. Five-year small boat launching ramps program;

3 administration. There is hereby created a program to provide  
4 small boat launching ramps and marina over a period of five (5)  
5 years commencing July 1, 1974. The program shall include  
6 preparation of engineering plans and specifications, the  
7 paving of access roads, the construction of parking facilities,  
8 the construction of ramps, and if necessary, the acquisition of  
9 access roads and parking facilities, and the dredging of  
10 channels for launching. The administration of this program  
11 shall be under the supervision of the Director of Commerce.

12 Section 2. No funds appropriated for this program may be  
13 expended except for engineering plans and specifications for  
14 construction purposes until fifteen (15) legislative days  
15 have elapsed from the date on which the Director of Commerce  
16 submits, and he is hereby directed to submit, to the Legislature  
17 the cost for each project herein authorized.

Section 3. There is hereby authorized to be appropriated,  
19 from the Unappropriated Surplus of the General Fund the sum of  
20 Two Million Four Hundred Thousand Dollars (\$2,400,000). This  
21 authorization shall be reduced by the sum of any Federal grants-  
22 in-aid provided for the purposes of this program and shall  
23 be apportioned among the following municipal districts of Guam
