AN ACT TO AMEND SECTION 2063 OF THE  
GOVERNMENT CODE OF GUAM TO INCREASE  
THE COMPENSATION OF REGISTRATION  
CLERKS FROM TEN DOLLARS (\$10.00) FOR  
EACH DAY OF REGISTRATION TO FOUR DOLLARS  
(\$4) AN HOUR WITH ADDITIONAL COMPENSATION  
FOR OVERTIME.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Section 2063 of the Government Code of Guam  
3 is hereby amended to read as follows:

4 "Section 2063. Same: compensation. Any person who  
5 is appointed a Registration Clerk shall receive compensation  
6 at a rate of Four Dollars (\$4) an hour, but the rate shall  
7 be Six Dollars (\$6) an hour for work in excess of eight (8)  
8 hours in any twenty-four (24) hour period. Any employee  
9 of the government of Guam who is appointed to be a  
10 Registration Clerk and who performs such duties during  
11 normal working hours shall not be entitled to receive the  
12 compensation authorized by this section."
