AN ACT TO ADD A NEW SUBSECTION 6 TO SECTION 9309, SUBSECTION 7 TO SECTION 9315 AND SUBSECTION 5 TO SECTION 9318 OF CHAPTER IV, TITLE X, OF THE GOVERNMENT CODE OF GUAM, RELATIVE TO DIRECTING THE DIRECTOR OF PUBLIC HEALTH AND SOCIAL SERVICES TO ACCEPT FOR RECORDATION PURPOSES CERTAIN RECORDS FROM OUTSIDE THE TERRITORY OF GUAM.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. A new Subsection 6 is hereby added to Section

9309 of Chapter IV, Title X of the Government Code of Guam to

read as follows:

- "6. The Director shall accept, for the purpose of recordation, certified copies of birth certificates of children born outside the territory of Guam to residents of Guam."
- Section 2. A new Subsection 7 is hereby added to Section 9315 of Chapter IV, Title X of the Government Code of Guam to read as follows:
- "7. The Director shall accept, for purposes of recordation, certified copies of death certificates of residents of Guam who die outside the territory of Guam."

 Section 3. A new Subsection 5 is hereby added to Section 9318 of Chapter IV, Title X of the Government Code of Guam to read as follows:
 - "5. The Director shall accept, for the purpose of recordation, certified copies of records of marriages performed outside the territory of Guam in which one or both parties are residents of Guam."
