



AN ACT TO ADD A NEW SUBSECTION 6 TO SECTION 9309, SUBSECTION 7 TO SECTION 9315 AND SUBSECTION 5 TO SECTION 9318 OF CHAPTER IV, TITLE X, OF THE GOVERNMENT CODE OF GUAM, RELATIVE TO DIRECTING THE DIRECTOR OF PUBLIC HEALTH AND SOCIAL SERVICES TO ACCEPT FOR RECORDATION PURPOSES CERTAIN RECORDS FROM OUTSIDE THE TERRITORY OF GUAM.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. A new Subsection 6 is hereby added to Section
3 9309 of Chapter IV, Title X of the Government Code of Guam to
4 read as follows:

5 "6. The Director shall accept, for the purpose
6 of recordation, certified copies of birth certificates of
7 children born outside the territory of Guam to residents
8 of Guam."

9 Section 2. A new Subsection 7 is hereby added to Section
10 9315 of Chapter IV, Title X of the Government Code of Guam to
11 read as follows:

12 "7. The Director shall accept, for purposes of
13 recordation, certified copies of death certificates of
14 residents of Guam who die outside the territory of Guam."

15 Section 3. A new Subsection 5 is hereby added to Section
16 9318 of Chapter IV, Title X of the Government Code of Guam to
17 read as follows:

18 "5. The Director shall accept, for the purpose of
19 recordation, certified copies of records of marriages
20 performed outside the territory of Guam in which one or
21 both parties are residents of Guam."
