AN ACT TO ADD SECTIONS 4020.1 AND
4020.2 TO THE GOVERNMENT CODE OF
GUAM TO AUTHORIZE GROUP AUTOMOBILE
AND HOME MORTGAGE INSURANCE FOR
GOVERNMENT OF GUAM EMPLOYEES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Section 4020.1 is hereby added to the Government
3 Code of Guam to read as follows:

4 "Section 4020.1. Group automobile insurance. (a)
5 The Governor is authorized to enter into contracts with
6 one or more insurance companies authorized to do business
7 in Guam for group automobile insurance for all employees,
8 or separate groups of employees, of the government of
9 Guam, for the insurance of their private vehicles.

10 (b) All participation by employees in such con-
11 tracts of automobile insurance shall be on a voluntary
12 basis. The government of Guam shall provide payroll
13 deduction for the payment of such premiums.

14 (c) 'Employees' as used in this section includes
15 officers and retired employees and survivors of retired
16 employees who are receiving annuity benefits."

17 Section 2. Section 4020.2 is hereby added to the Government
18 Code of Guam to read as follows:

19 "Section 4020.2. Group Home Mortgage Insurance.

20 (a) The Governor is authorized to enter into
21 contracts with one or more insurance companies authorized
22 to do business in Guam for home mortgage insurance for

1 all employees or separate groups of employees of the
2 government of Guam.

3 (b) All participation by employee in such con-
4 tracts of home mortgage insurance shall be on a voluntary
5 basis. The government of Guam shall also provide payroll
6 deductions for the payment of premiums.

7 (c) 'Employees' as used in this section includes
8 officers and retired employees and survivors of retired
9 employees who are receiving annuity benefits."
