



CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR





AN ACT MAKING TRANSFERS AND APPROPRIATIONS
TO PROVIDE AMBULANCE SERVICE FOR THE
VILLAGES OF YONA AND SANTA RITA, AND FOR
CONSTRUCTION OF TWO-LANE PAVED ROAD IN YIGO.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby transferred to the General
3 Fund from the Hospital Construction Fund the sum of ~~Seventy~~ ^{Twenty}
4 ~~Five Thousand Dollars~~ ^(\$20,000) ~~(\$75,000)~~, which sum is hereby appropriated,
5 to provide for an ambulance to serve the village of Yona.

6 Section 2. There is hereby transferred to the General
7 Fund from the Hospital Construction Fund the sum of ~~One Hundred~~ ^{Z E R O}
8 ~~Eighty Thousand Dollars~~ ⁽⁰⁾ ~~(\$180,000)~~, which sum is hereby appro-
9 priated, for the purpose of constructing a two-lane paved road
10 in Yigo within the Takano, Salas and Bordallo Subdivisions.
