AN ACT MAKING AN APPROPRIATION FROM THE
UNAPPROPRIATED SURPLUS OF THE GENERAL
FUND TO THE PUBLIC UTILITY AGENCY OF
GUAM FUND FOR THE FISCAL YEAR ENDING
JUNE 30, 1975.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any
3 Unappropriated Surplus of the General Fund the sum of Two
4 Million Four Hundred Ninety-Seven Thousand One Hundred
5 Twenty-One Dollars (\$2,497,121.00) to the Public Utility
6 Agency Fund to pay salaries of the employees of the Public
7 Utility Agency of Guam and to satisfy other unpaid obligations
8 of that agency for the fiscal year ending June 30, 1975.

9 Section 2. There is hereby transferred the sum of Two
10 Million Four Hundred Ninety-Seven Thousand One Hundred
11 Twenty-One Dollars (\$2,497,121.00) from the Hospital
12 Construction Fund to the General Fund to satisfy the appro-
13 priation made by Section 1 of this Act.

14 Section 3. Notwithstanding any law, rule or regulation
15 to the contrary, the Director, Department of Administration,
16 shall be the Certifying Officer of any expenditures of the
17 funds herein appropriated and shall make certification
18 thereof only when he is satisfied that the Public Utility
19 Agency Fund has insufficient cash to pay the employees of
20 that agency or satisfy other unpaid obligations thereof.
21 The Chief Officer of the Public Utility Agency of Guam shall
22 file with the Thirteenth Guam Legislature a report no later
23 than the 15th day of each and every month delineating and

1 providing an explanation for the expenditures charged against
2 the appropriation herein provided and it shall be the duty
3 of the Director, Department of Administration, to assist the
4 Chief Officer of the Public Utility Agency of Guam and to
5 co-author said monthly report.

6 Section 4. Effective July 1, 1975, the sum of Three
7 Million Two Hundred Twenty-Two Thousand One Hundred Twenty-
8 One Dollars (\$3,222,121) is hereby transferred from any
9 available balance of the Unappropriated Surplus of the
10 General Fund to the Hospital Construction Fund. The sum
11 herein transferred is not an appropriation and shall not be
12 committed nor expended until appropriated subsequently by
13 the Legislature.
