Bill No. 129

Introduced by R. F. Taitano

AN ACT AUTHORIZING AND DIRECTING THE  
GOVERNOR OF GUAM TO EXCHANGE CERTAIN  
LOTS IN DEDEDO AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. The Governor of Guam is authorized and  
3 directed to direct the Department of Land Management to  
4 begin negotiations with all those private landowners whose  
5 land has been taken without compensation by the Government  
6 of Guam for a right-of-way for the exchange of those lands  
7 for Government land on a value for value basis.

8 Section 2. The Governor of Guam is authorized and  
9 directed to exchange a portion of Lot 10133, an area  
10 consisting of 4152.7 square meters belonging to the govern-  
11 ment of Guam for Lot 10070-A-1 Dededo consisting of 4152.7  
12 square meters.

13 Section 3. The exchange in Section 2 authorized is for  
14 the purpose of obtaining a part of the right-of-way for  
15 the Y-Sengsong Road in the municipality of Dededo.

16 Section 4. The Governor, notwithstanding any other  
17 provisions of law, is authorized to exchange and grant to  
18 the owners of that portion of basic Lot 3376-R2, municipality  
19 of Sinajana, within the Maimai Road easement with equal area of  
20 Government of Guam land within Lot 7066 Rem-1, municipality  
21 of Yigo along Route 1. The land so taken is shown on Drawing  
22 7309-93 which is filed in the Department of Land Management  
23 as map 133-FY74. The total exchange area within Lot 7066-Rem-1  
24 authorized to be conveyed shall be apportioned among the owners  
25 of the three lots as they and the Governor may negotiate.
