

Bill No. 429

Introduced by G. R. Salas

AN ACT TO ADD A NEW SECTION 59019 TO  
TITLE LXIV, CHAPTER I OF THE GOVERNMENT  
CODE (PUBLIC LAW 13-26) TO PROVIDE THAT  
ALL NET GOVERNMENTAL REVENUES DERIVED  
FROM THE OPERATION OF THE TERRITORIAL  
GREYHOUND RACING COMMISSION BE PLACED IN  
THE HOSPITAL CONSTRUCTION FUND.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. A new Section 59019 is added to Title LXIV,  
3 Chapter I of the Government Code (Public Law 13-26) to read:

4 "Section 59019. Notwithstanding any other provisions  
5 of law, all net governmental revenues derived from the  
6 operation of the Territorial Greyhound Racing Commission  
7 shall be placed in the Hospital Construction Fund to be  
8 used for the purposes of that Fund.

9 (a) The Commission shall promulgate the necessary  
10 rules and regulations to executed the provisions of this  
11 Section.

12 (b) Nothing herein shall be construed to preclude  
13 or interfere with other provisions of Title LXIV, Chapter I  
14 of the Government Code (Public Law 13-26) that now require  
15 the Commission to make an annual audited financial state-  
16 ment to the Governor and annual reports of receipts to  
17 the Governor and to the Legislature."
