AN ACT TO TRANSFER THE FUNDS IN THE GUAM MEMORIAL HOSPITAL FUND AND THE SUSANA HOSPITAL FUND TO THE GENERAL FUND, TO REPEAL SECTIONS 49011, 49012, AND 49013. OF THE GOVERNMENT CODE OF GUAM AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. The Guam Memorial Hospital Fund and the Susana Hospital Fund are hereby closed. The monies in said funds are transferred to the General Fund Unappropriated Surplus.

Section 2. Sections 49011, 49012 and 49013 of the Government Code of Guam are hereby repealed.

Section 3. Section 19374 of the Government Code is hereby repealed and reenacted to read:

"Section 19374. Delinquent: Date: Penalties.

All taxes due December 15 if unpaid, are delinquent February

20 of the following year at 12:00 midnight, and thereafter

a delinquent penalty attached to them in an amount equal

to nine percent (9%); provided, however, that the minimum

penalty under this Sections shall be Five Dollars (\$5.00)."

Section 4. Section 19375 of the Government Code is hereby

repealed and reenacted to read:

"Section 19375. Same: Same: Same. All taxes due
February 20 if unpaid are delinquent April 20 of each year
at 12:00 midnight and thereafter a delinquent penalty
attached to them in an amount equal to nine percent (9%);
provided, however, that the minimum penalty under this
Section shall be Five Dollars (\$5.00)."
