Public Law 13-99 Thirteenth Guam Legislature (Bill 492)

AN ACT

An Act to appropriate the sum of Two Thousand Two Hundred and Fifty Dollars (\$2,250) for the purpose of matching federal grant-in-aid funds for project help.

Be it enacted by the People of the Territory of Guam:

Section 1. There is appropriated the sum of Two Thousand Two Hundred Fifty Dollars (\$2,250) from the Unappropriated Surplus of the General Fund to Project Help (Sanctuary, Inc.) to be used by said Project Help as a local matching fund to match federal grant-in-aid funds.

Section 2. Notwithstanding any other law, rule or regulation to the contrary, the appropriation provided for herein shall be paid by the Treasurer of Guam directly to the Director of Project Help.
