




AN ACT TO RE-IDENTIFY THREE THOUSAND DOLLARS
(\$3,000) OF THE PARKS AND RECREATION FISCAL
YEAR 1975 BUDGET AS AMENDED (PUBLIC LAW 12-150)
AS LOCAL MATCHING TO THE FEDERAL GRANTS-IN-AID
(LEAA FUNDS) AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Only the following item of part of Section
3 VI.A of Public Law 12-150 is hereby amended to read as follows:

4 "VI. Parks and Recreation

5 A. Guam Recreation Commission

6 8. The appropriation made pursuant to
7 Subsection 2.VI.A.1 through 2.VI.A.7 shall
8 include Twenty-Seven Thousand Dollars
9 (\$27,000) of Federal Grants-in-Aid, additionally,
10 the amount of Three Thousand Dollars (\$3,000)
11 appropriated pursuant to Subsection VI.A.1 thru
12 7 from the General Fund is hereby specifically
13 identified as local matching to the Federal
14 Grants-in-Aid (LEAA Funds)."

15 Section 2. Section 1 of this Act shall be effective upon
16 its enactment.

17 Section 3. Section 1 of Public Law 15-27 is amended
18 to read:

19 "Section 1. Notwithstanding any provision of law,
20 rules, or regulations to the contrary, the sum of One
21 Six Thousand Ninety-Seven Dollars (\$16,997) is hereby
22 appropriated from any available fund in the Unappropriated
23 Surplus of the Tourism Attraction Fund for the payment
24 of the fifth annual Pacific Guam Commission fee for the period

commencing January 1, 1973, and ending December 31, 1975, said sums to be transferred to the Guam South Pacific Games Commission and to be allocated as follows:¹¹

Section 4. Section II.E.1 and 5 of Public Law 13-37 is amended as follows:
