

CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR

This is to certify that Substitute Bill No. 884, "An Act making an appropriation for the Special Commission of the Political Status of Guam", which was heretofore passed and thereafter on July 27, 1976, returned to the Legislature without the approval of the Governor was, in accordance with the Organic Act of Guam, reconsidered by the Legislature and after such reconsideration the Legislature did on the 28th day of July, 1976, agree to pass said bill notwithstanding the objections of the Governor by a vote of two-thirds of all the members thereof, to wit: by a vote of 14 members.



AN ACT MAKING AN APPROPRIATION FOR THE
SPECIAL COMMISSION ON THE POLITICAL
STATUS OF GUAM.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section. The sum of Twenty-Five Thousand Dollars
3 (\$25,000.00) is appropriated from the General Fund to the
4 Special Commission on the Political Status of Guam for the
5 specific purpose of conducting an educational program on the
6 political status referendum to be conducted on September 4,
7 1976.

8 Section 2. Unexpended or unencumbered balances from the
9 appropriation made in Section 1 of this Act shall revert back
10 to the General Fund no later than September 3, 1976.

11 Section 3. The sum of Twenty-Five Thousand Dollars
12 (\$25,000.00) is appropriated from the General Fund to the
13 Special Commission on the Political Status of Guam for the
14 purpose of defraying expenses incurred as a result of status
15 negotiations with representatives of the federal government.

16 Section 4. Unexpended or unencumbered balances from the
17 appropriation made in Section 3 of this Act shall revert back
18 to the General Fund no later than June 30, 1978.

19 Section 5. The sum of Six Thousand Five Hundred Dollars
20 (\$6,500.00) is appropriated from the General Fund to the
21 Guam Election Commission for the purpose of defraying the
22 additional expenses incurred by the Commission in carrying
23 out the referendum on political status.
