AN ACT TO APPROPRIATE \$3,000 TO ALLOW THE GOVERNMENT OF GUAM TO AID IN THE COST TO INSTALL AN ADEQUATE AIR CONDITIONING SYSTEM WITHIN THE PHYSICAL EDUCATION LOCKER ROOMS IN THE GEORGE WASHINGTON SENIOR HIGH SCHOOL GYM AND FOR OTHER PURPOSES.

STATEMENT OF LEGISLATIVE FINDINGS: The ventilation system in the two physical education locker rooms have been found to be inadequate. On many occasions the temperature in the locker room have been found to be twenty degrees higher than the temperature outside. Reports of faintings, dizziness, and growing weak have been noted due to such high temperatures. The absence of adequate ventilation also causes excess humidity to build up within the room causing clothing to stale and students to sweat more even after they have showered. It would be in the best interest of the government to provide additional funds to air condition the locker rooms for the welfare and health of our school children. The additional \$3,000 is needed to supplement the \$14,000 raised by the students of the George Washington Senior High School.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. There is hereby appropriated from the General Fund Three Thousand Dollars (\$3,000) to be used for the installation of an adequate air conditioning system within the physical education locker rooms in the George Washington Senior High School gym.

Section 2. Maximum effort will be exerted to complete this project before School Year 1977-1978. Any balance remaining on December 31, 1977 of the appropriation made under Section 1 shall revert to the General Fund.

Section 3. Section 1, VI., Item B., of Public Law 10-171
Tenth Guam Legislature, as amended by P.L. 11-6 is further amended to read as follows:

"B. Park Development \$70,000"

Section 4. Public Law 13-182 is hereby repealed in its entirety.
