AN ACT TO ADD A SUBSECTION (g) OF SECTION
21001 OF THE GOVERNMENT CODE TO PROHIBIT
COMMISSIONERS OF THE PUBLIC UTILITIES
COMMISSION FROM ACCEPTING JOBS WITH A
REGULATED INDUSTRY FOR A PERIOD OF TWO
YEARS AFTER SERVING ON THE COMMISSION.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. A new Subsection (g) is added to Section
3 21001 of the Government Code to read:

4 "(g) No Commissioner shall during the two (2)
5 years immediately following termination of his term
6 as a Commissioner be employed by any industry which
7 is regulated by the Commission."

8 Section 2. Section 21005 of the Government Code is
9 amended to read:

10 "Section 21005. Investigative powers. The
11 Commission and each Commissioner shall have the
12 power to examine into the condition of each public
13 utility, the manner in which it is operated with

reference to the safety or accommodation of the public, the safety, working hours, and wages of its employees, the fares and rates charged by it, the value of its physical property, the issuance by it of stocks and bonds, and the disposition of the proceeds thereof, the amount and disposition of its income, and all its financial transactions, its business relations with other persons, companies, or corporations, its compliance with all applicable territorial and federal laws and with the provisions of its franchise, charter, articles of incorporation, and enabling legislation, if any, its classifications, rules, regulations, practices, and service, and all matters of every nature affecting the relations and transactions between it and the public or persons or corporations. Any investigation may be made by the Commission of its own motion, and shall be made when requested by the public utility to be investigated, or upon a sworn written complaint to the Commission, setting forth any prima facie cause of complaints, or upon an appeal submitted pursuant to Section 21153 and Section 21154 of the Government Code. A majority of the Commission shall constitute a quorum."

Section 3. Notwithstanding any law, rule, or regulation to the contrary, those government of Guam retirees whose average annual salary was computed to include overtime payments, night differential, hazardous duty pay or lump sum payments for annual leave shall not be required by the Board of Trustees of the Retirement Fund to reimburse the fund for any annuity payments based on said computation,

1 nor shall said annuity payments be reduced.

2 Section 4. The appropriations made in Part One, Section 1,
3 Subsections (d), B., 1, 2, 3 and 5 of Public Law 13-149 are
4 amended to read:

5 "(d) EDUCATION

6 B. Museum

- 7 1. For Personnel Services,
8 not to exceed \$ 8,652
9 2. For Personnel Benefits,
10 not to exceed \$ 1,070
11 3. For Contractual Services,
12 not to exceed \$10,102
13 4. For equipment, not
14 to exceed - 0 -"

15 Section 5. Sections 1, 2 and 3 of this Act shall be
16 effective upon enactment into law.
