AN ACT TO CANCEL CERTAIN APPROPRIATIONS.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. All provisions of law containing appropriations for capital projects which were enacted into law thirty-six (36) months prior to the effective date of this Act are hereby repealed; however, this section shall only be applicable to capital projects determined by the Governor no later than February 29, 1980, to be financially not feasible or projects determined to have been completed with idle balances remaining in the project account. All such balances shall revert to the applicable fund source from which the project was appropriated.

Section 2. On the effective date of this Act, any surplus or lapsed funds remaining in the applicable fund source from which the project was appropriated shall be applied to the projects which were not cancelled by Section 1 of this Act and which have not been completely funded.

Section 3. At the conclusion of any fiscal year, any surplus or lapsed funds remaining in the applicable fund source from which the project was appropriated shall be applied to projects which were not cancelled by Section 1 of this Act and which have not been completely funded.

Section 4. The Director of the Bureau of Budget and Management Research shall report to the Legislature no later than March 31, 1980: (1) all projects cancelled by Section 1 of this Act citing the provision of law repealed; (2) all projects to be funded in accordance with Section 2 and Section 3 of this Act and funds required; and (3) all expenditures made pursuant to 7 the provisions of this Act.
