





AN ACT TO APPROPRIATE SEVENTY-EIGHT
THOUSAND DOLLARS (\$78,000) TO THE
DEPARTMENT OF PUBLIC WORKS TO
RESURFACE NAVAL MAGAZINE ROAD AND
FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated the sum of Seventy-
3 Eight Thousand Dollars (\$78,000) from the Territorial Highway
4 Fund to the Department of Public Works to repair and resurface
5 Naval Magazine Road.

6 Section 2. Any available balance of the appropriation in
7 Section 1 of this measure after September 30, 1980 shall revert
8 back to the Territorial Highway Fund.

9 Section 3. There is hereby appropriated from the General
10 Fund to the Guam Memorial Hospital Authority the sum of One
11 Million Six Hundred Sixty-One Thousand Six Hundred Thirty-Nine
12 Dollars (\$1,661,639). Said sum is to be expended by Guam
13 Memorial Hospital Authority for the following obligations:

14 1) Government of Guam Retirement
15 Fund Contributions \$664,194
16 2) Withholding Taxes \$997,445.

1 Section 4. All sums owed to the Guam Memorial Hospital
2 Authority by the Departments of Corrections, Education, Public
3 Safety and the Superior Court through December 31, 1979 are
4 hereby forgiven.

5 Section 5. The sum of Two Hundred Fifty Thousand Dollars
6 (\$250,000) is hereby appropriated from the General Fund for the
7 plans and construction of an indoor gymnasium at Luis P. Untalan
8 Junior High School in Barrigada. *MC*

9 *MC* Section 6. The sum of ^{Twelve Thousand} ~~Twenty-Two Thousand~~ Dollars
10 (\$12,000) ~~(\$22,000)~~ is hereby appropriated from the General Fund for the
11 refurbishing of the Basketball and Volleyball courts in
12 Inarajan.

13 Section 7. Section 6 of Public Law 14-120 is hereby amended
14 to read:

15 "Section 6. The sum of Sixty Thousand Dollars (\$60,000)
16 is appropriated from the Unappropriated Surplus of the
17 General Fund for the improvements at the Guzman Memorial
18 Baseball Field in the municipality of Santa Rita."

19 *MC* Section 8. The sum of ^{ZERO} ~~Twenty-Thousand~~ Dollars ^{*MC* 0} (\$20,000)
20 is hereby appropriated from the General Fund to upgrade the field
21 lighting system of the Jose U. Atoigue Baseball Park in Chalan
22 Pago.

23 Section 9. In complete satisfaction of all claims, demands
24 and causes of actions of Maria Q. Ariano which do arise out of
25 Civil Case No. 240-73, the sum of ^{*MC* ZERO} ~~Twenty-Two-Thousand-Two-Hundred~~
26 ~~Fifty-Dollars~~ ^{*MC* 0} (\$22,250) is hereby appropriated from the General
27 Fund to satisfy her claim arising out of judgement and interest
28 accrued to date by Civil Case No. 240-73.
