


CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR





AN ACT TO APPROPRIATE THE SUM OF
ONE HUNDRED THOUSAND DOLLARS
(\$100,000) TO THE DEPARTMENT OF
PUBLIC WORKS FOR THE CONSTRUCTION
OF A CEMENT CULVERT TO CHANNEL THE
WATERS OF THE SALINAS RIVER THROUGH
NEW AGAT.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from the General
3 Fund the sum One Hundred Thousand Dollars (\$100,000) to the
4 Department of Public Works for the construction of a cement
5 culvert to channel the waters of the Salinas River through
6 Block 8 in New Agat.

7 Section 2. Any available balance of the appropriation in
8 Section 1 of this measure after December 30, 1980 shall revert to
9 the Unappropriated Surplus of the General Fund.

10 Section 3. Section 1 of Public Law 13-122 is amended to
11 read:

12 "Section 1. Section 1 of Public Law 12-159 is hereby
13 repealed and a new Section 1 is hereby enacted to read as
14 follows:

15 'Section 1. There is hereby appropriated the
16 sum of Three Million Three Hundred Two Thousand Three
17 Hundred Eighty Dollars (\$3,302,380) to include One
18 Million Two Hundred Fifty-Seven Thousand Three
19 Hundred Eighty Dollars (\$1,257,380) of Federal

1 Environmental Protection Agency matching funds, Two
2 Hundred Twenty-Five Thousand Dollars (\$225,000) of
3 Guam Rehabilitation Loan Fund and One Million Eight
4 Hundred Twenty Thousand Dollars (\$1,820,000) from the
5 General Fund for the Chalan Pago/Ordot Sewer System,
6 Mangilao Sewer System and Agat-Nimitz Sewer System to
7 be apportioned as follows:

8 1. For Chalan Pago/Ordot Sewer
9 System, \$1,367,130 of which

10	Federal EPA	\$622,130
11	Guam Rehabilitation Fund	\$225,000
12	General Fund	\$520,000

13 2. For Mangilao Sewer System,
14 \$1,205,250 of which

15	Federal EPA	\$635,250
16	General Fund	\$570,000

17 3. For Agat-Nimitz Sewer
18 System, \$730,000 of which

19	General Fund	\$730,000".

20 Section 4. The sum of Seventy Thousand Dollars (\$70,000)
21 is hereby appropriated from the General Fund to place a culvert
22 near the Truman Elementary School in the municipality of Santa
23 Rita.

24 *J. A. A.* Section 5. The sum of ~~Seventy-Five-Thousand-Dollars-~~
25 ~~(\$75,000)~~ is appropriated from the Territorial Highway Fund to
26 the Department of Public Works for the design and construction
27 of two (2) secondary access roads in Tamuning: Pas Street and
28 Paraiso Street and to improve the drainage system along Unada
29 Street to prevent flooding from Chalan San Antonio.

1 Section 6. The sum of Ten Thousand Dollars (\$10,000) is
2 appropriated from the General Fund to the Department of Public
3 Health and Social Services for the disposition of unclaimed
4 dead human bodies. The appropriation made by this Section shall
5 remain available until fully expended.

6 Section 7. Section 4 of Public Law 15-93 is hereby amended
7 to read:

8 "Section 4. Sections 1 and 2 of this Act shall take
9 effect on September 1, 1980."

10 Section 8. The sum of Two Hundred Five Thousand Two
11 Hundred Dollars (\$205,200) is hereby appropriated from the
12 General Fund for paving two (2) streets: in the Talisay area
13 of Santa Rita (Tract 176) and on Padre Palomo Court within
14 Santa Rita proper.

15 Section 9. There is hereby authorized to be appropriated
16 from the General Fund to the Department of Public Works the sum
17 of Seven Hundred Thousand Dollars (\$700,000) for the completion
18 of the culverts to channel the waters of the Salinas River
19 through the village of Agat.

20 Section 10. The sum of Six Thousand Dollars (\$6,000) is
21 appropriated from the General Fund to the Department of Youth
22 Affairs for the purpose of paying the travel and other expenses
23 of a professional football player to conduct a clinic and make
24 other appearances during Youth Month 1980.

25 Section 11. There is hereby appropriated from the General
26 Fund the sum of Twenty Two Thousand Two Hundred Fifty Dollars
27 (\$22,250) to the Land Acquisition Fund to satisfy the judgement
28 and interest accrued by Civil Case No. 240-73.
