AN ACT TO APPROPRIATE THE SUM OF ONE HUNDRED THOUSAND DOLLARS (\$100,000) TO THE DEPARTMENT OF PUBLIC WORKS FOR THE CONSTRUCTION OF A CEMENT CULVERT TO CHANNEL THE WATERS OF THE SALINAS RIVER THROUGH NEW AGAT.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

There is hereby appropriated from the General Section 1. Fund the sum One Hundred Thousand Dollars (\$100,000) to the Department of Public Works for the construction of a cement culvert to channel the waters of the Salinas River through Block 8 in New Agat.

Section 2. Any available balance of the appropriation in Section 1 of this measure after December 30, 1980 shall revert to the Unappropriated Surplus of the General Fund.

Section 3. Section 1 of Public Law 13-122 is amended to read:

Section 1 of Public Law 12-159 is hereby "Section 1. repealed and a new Section 1 is hereby enacted to read as follows:

There is hereby appropriated the 'Section 1. sum of Three Million Three Hundred Two Thousand Three Hundred Eighty Dollars (\$3,302,380) to include One Million Two Hundred Fifty-Seven Thousand Three Hundred Eighty Dollars (\$1,257,380) of Federal

Environmental Protection Agency matching funds, Two Hundred Twenty-Five Thousand Dollars (\$225,000) of Guam Rehabilitation Loan Fund and One Million Eight Hundred Twenty Thousand Dollars (\$1,820,000) from the General Fund for the Chalan Pago/Ordot Sewer System, Mangilao Sewer System and Agat-Nimitz Sewer System to be apportioned as follows:

1. For Chalan Pago/Ordot Sewer System, \$1,367,130 of which Federal EPA \$622,130 Guam Rehabilitation Fund \$225,000 General Fund \$520,000 For Mangilao Sewer System, \$1,205,250 of which Federal EPA \$635,250 \$570,000 General Fund 3. For Agat-Nimitz Sewer System, \$730,000 of which

\$730,000".

Section 4. The sum of Seventy Thousand Dollars (\$70,000) is hereby appropriated from the General Fund to place a culvert near the Truman Elementary School in the municipality of Santa Rita.

General Fund

Section 5. The sum of Seventy-Five-Thousand-Dollars-(\$75,000) is appropriated from the Territorial Highway Fund to the Department of Public Works for the design and construction of two (2) secondary access roads in Tamuning: Pas Street and Paraiso Street and to improve the drainage system along Unada Street to prevent flooding from Chalan San Antonio.

Section 6. The sum of Ten Thousand Dollars (\$10,000) is appropriated from the General Fund to the Department of Public Health and Social Services for the disposition of unclaimed dead human bodies. The appropriation made by this Section shall remain available until fully expended.

Section 7. Section 4 of Public Law 15-93 is hereby amended to read:

"Section 4. Sections 1 and 2 of this Act shall take effect on September 1, 1980."

Section 8. The sum of Two Hundred Five Thousand Two Hundred Dollars (\$205,200) is hereby appropriated from the General Fund for paving two (2) streets: in the Talisay area of Santa Rita (Tract 176) and on Padre Palomo Court within Santa Rita proper.

Section 9. There is hereby authorized to be appropriated from the General Fund to the Department of Public Works the sum of Seven Hundred Thousand Dollars (\$700,000) for the completion of the culverts to channel the waters of the Salinas River through the village of Agat.

Section 10. The sum of Six Thousand Dollars (\$6,000) is appropriated from the General Fund to the Department of Youth Affairs for the purpose of paying the travel and other expenses of a professional football player to conduct a clinic and make other appearances during Youth Month 1980.

Section 11. There is hereby appropriated from the General Fund the sum of Twenty Two Thousand Two Hundred Fifty Dollars (\$22,250) to the Land Acquisition Fund to satisfy the judgement and interest accrued by Civil Case No. 240-73.
