




CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR



Bill No. 617

Introduced by F. R. Santos

AN ACT TO AMEND SECTION 688 OF THE CIVIL
PROCEDURE CODE RELATIVE TO RELEASE FROM
LEVY OF PROPERTY LIABLE TO EXECUTION.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Section 688 of the Civil Procedure Code is
3 hereby amended to read as follows:

4 "Section 688. Property liable to execution: not
5 affected until levied on. All goods, chattels, moneys
6 or other property, both real and personal, or any
7 interest therein, of the judgment debtor, not exempt
8 by law, and all property and rights of property seized
9 and held under attachment in the action, are liable
10 to execution. Shares and interests in any corporation
11 or company, and debts and credits, and all other
12 property, both real and personal, or any interests in
13 either real or personal property, and all other
14 property not capable of manual delivery, may be levied
15 upon or released from levy in like manner as like
16 property may be attached or released from attachment,
17 except that a copy of the complaint in the action from
18 which the writ issued need not accompany the writ;
19 provided, that no cause of action nor judgement as such,
20 nor license issued by this territory to engage in any
21 business, profession, or activity shall be subject to

1 levy or sale on execution. Until a levy, the property
2 is not affected by the execution; but no levy shall
3 bind any property for a longer period than one (1) year
4 from the date of the issuance of the execution, except
5 a levy on the interests or claims of heirs, devisees,
6 or legatees in or to assets of deceased persons remaining
7 in the hands of executors or administrators, thereof
8 prior to distribution and payment. However, an alias
9 execution may be issued on said judgment and levied on
10 any property not exempt from execution."

11 Section 2. The Compiler of Laws shall assign new section
12 numbers in Title I of the Guam Code Annotated to Sections 325 and
13 326 of the Government Code enacted in Public Law 15-105. Sections
14 325 and 326 as enacted in Public Law 15-105 shall not be deemed
15 repealed by Public Law 15-104.
