AN ACT TO DESIGNATE AS PEACE OFFICERS THE EMPLOYEES OF THE DEPARTMENT OF YOUTH AFFAIRS WHO ARE ENGAGED IN JUVENILE DETENTION AND REHABILITATION WORK.

BE IT ENACTED BY THE PROPLE OF THE TERRITORY OF GUAM:

Section 1. A new Subsection (j) is added to Section 5.55 of the Criminal Procedure Code to read:

- "(j) employees of the Department of Youth Affairs who are engaged in juvenile detention and rehabilitation work as designated by the Director of the Department of Youth Affairs."
- Section 2. A new item (xi) is added to Subsection (c) of Section 4020.1 of the Government Code to read:
  - "(xi) employees of the Department of Youth Affairs who are engaged in juvenile detention and rehabilitation work as designated by the Director of Youth Affairs."
