AN ACT TO AMEND SECTION 21563 OF CHAPTER VII, TITLE XXII OF THE GOVERNMENT CODE RELATIVE TO THE INTEREST RATE OF GUAM POWER AUTHORITY REVENUE BONDS.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Section 21563 of Chapter VII, Title XXII of the Government Code is amended to read:

Section 21563. Interest on bonds. (a) Bonds shall bear interest at a rate of not to exceed nine percent (9%) per annum, payable annually or semi-annually or in part annually and in part semi-annually except that the first coupon on any bond may be payable any number of months less than twelve (12) after the date of such bond.

(b) The interest rate on the refinancing of the \$36 Million Pollar loan from the Federal Financing Bank (as provided in Public Law 96-205) shall be at the rate established in accordance with Public Law 96-205. Interest may be payable annually or semi-annually or in part annually and in part semi-annually except that the first coupon on any bond may be payable any number of months less than twelve (12) after the date of such bond."
