


CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR





AN ACT TO APPROPRIATE TWENTY-FIVE THOUSAND
DOLLARS (\$25,000) TO THE 1979 GUAM SPECIAL
OLYMPICS COMMITTEE TO PARTICIPATE IN THE
1979 INTERNATIONAL SUMMER OLYMPIC GAMES IN
BROCKPORT, NEW YORK.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. The sum of Twenty-Five Thousand Dollars
3 (\$25,000) is hereby appropriated from the General Fund to the
4 1979 Guam Special Olympics Committee to underwrite the cost of
5 travel and expenses incurred in participating in the 1979 Inter-
6 national Summer Olympic Games in Brockport, New York, on
7 August 9 thru 13, 1979.

8 Section 2. All sums not so expended pursuant to Section 1
9 of this Act as of January 1, 1980, shall revert to the General
10 Fund of Guam.
