AN ACT MAKING AN APPROPRIATION TO INSTALL AN ADEQUATE WATERLINE IN THE AS-LUCAS AND THE NOTRE DAME HIGH SCHOOL AREAS IN THE MUNICIPALITY OF TALOFOFO AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. The sum of One Hundred Fifty Thousand Dollars (\$150,000) is appropriated from the General Fund to the Public Utility Agency of Guam to replace waterlines and all required water pump equipment in the As-Lucas and Notre Dame High School areas within the municipality of Talofofo.

There is hereby appropriated from the General Section 2. Fund to the Department of Parks and Recreation the sum of Twenty-Six Thousand Dollars (\$26,000) to defray the expenses for balls and umpiring for the Little League, Big League and Babe Ruth League for the 1979 season.
