



CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR



AN ACT MAKING AN APPROPRIATION FOR THE
OPERATION OF THE FIFTEENTH GUAM LEGISLATURE
AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. The sum of Four Million Three Hundred Eighty-
3 Four Thousand Six Hundred Twelve Dollars (\$4,384,612) is
4 appropriated from the General Fund to the Legislative Operations
5 Fund for the operations of the Fifteenth Guam Legislature for the
6 calendar year ending December 31, 1980.

7 Section 2. Allocation of Appropriation. The sum appropri-
8 ated by this Act is a single item of appropriation which shall
9 be allocated by the Committee on Rules for expenditures in
10 accordance with the following, provided, however, the Committee
11 on Rules can reallocate the appropriation at any time.

12 A. For salaries of fourteen (14)
13 majority senators and fringe
14 benefits \$ 309,234

15 B. For the operation of the Standing
16 Committees, the Office of the
17 Speaker and Legislative Secretary
18 and to provide contingency funds
19 for the Speaker, Vice-Speaker,
20 Legislative Secretary, each of
21 the Standing Committees and the
22 Majority Leader as allocated by
23 the Committee on Rules \$1,477,000

2		Minority Senators including	
3		fringe benefits	\$ 154,357
4	D.	For the operation of the	
5		Minority Offices including	
6		a contingency fund for the	
7		Minority Leader	\$ 694,010
