AN ACT MAKING AN APPROPRIATION FOR THE OPERATION OF THE FIFTEENTH GUAM LEGISLATURE AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. The sum of Four Million Three Hundred Eighty-Four Thousand Six Hundred Twelve Dollars (\$4,384,612) is appropriated from the General Fund to the Legislative Operations Fund for the operations of the Fifteenth Guam Legislature for the calendar year ending December 31, 1980.

Section 2. Allocation of Appropriation. The sum appropriated by this Act is a single item of appropriation which shall be allocated by the Committee on Rules for expenditures in accordance with the following, provided, however, the Committee on Rules can reallocate the appropriation at any time.

and to provide contingency funds
