




CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR





AN ACT TO AMEND SECTION 6610.5 OF THE
GOVERNMENT CODE TO CHANGE THE MILEAGE
REIMBURSEMENT FROM TWENTY CENTS (20¢)
TO THIRTY CENTS (30¢) FOR ALL GOVERN-
MENT OF GUAM EMPLOYEES ON OFFICIAL
BUSINESS.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Section 6610.5 of the Government Code (as
3 amended in Public Law 14-119) is amended to read:

4 "Section 6610.5. Mileage allowance. Persons
5 authorized to travel at government expense shall, in
6 accordance with regulations and whenever such mode of
7 transportation is authorized or approved as more
8 advantageous to the government, be paid in lieu of
9 transportation not to exceed thirty cents (30¢) per
10 mile for the use of privately owned four-wheeled
11 passenger motor vehicles or ten cents (10¢) per mile
12 for the use of other types of privately owned vehicles,
13 when engaged on official business within or outside
14 their designated posts of duty. In addition to the
15 mileage allowance, there may be allowed reimbursement
16 for the actual cost of ferry fares and bridge, road
17 and tunnel fares."
