Section 1. Section 30030.1 is added to the Government
Code to read:

"Section 30030.1. A bank shall pay interest at a rate not less than that paid on regular passbook savings accounts as calculated by the individual banks on Guam on home mortgage escrow accounts."

Section 2. A new Section 41458.1 is added to the Government Code to read:

"Section 41458.1. An association shall pay interest at a rate not less than that paid on regular passbook savings accounts as calculated by the individual savings and loans on Guam on home mortgage escrow accounts."

Section 3. Section 17 of Public Law 14-127 is amended to read:

"Section 17. Section 3 of Public Law 14-73, which established an eleven (11) member Commission to recommend statutory revisions relative to territorially chartered saving and loan associations, is amended to read:
