



AN ACT TO AMEND SECTION 19543 OF THE
GOVERNMENT CODE TO EXEMPT FROM THE GROSS
RECEIPTS TAX AMOUNTS RECEIVED FROM SALE OF
RESIDUAL FUEL FOR MARINE PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. A new Subsection .1016 is added to Section
3 19543 of the Government Code to read:

4 ".1016. Amounts received from the sale of residual
5 fuel for marine purposes. As used in this subsection, 'residual
6 fuel' means that liquid which is the heaviest grade petroleum
7 product used in marine oil-burning boilers. It consists of
8 the residue of certain crude oils after the lighter fractions
9 such as benzine, kerosene, gas-oils and lubricating oils have
10 been removed by distillation."
