AN ACT TO AMEND SUBSECTION (b) OF SECTION 12311
OF THE GOVERNMENT CODE RELATIVE TO NET FISHING
WITHIN THE AGANA BOAT BASIN AND PROVIDING ASSIS-
TANCE FOR THE MARKETING OF FISH.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Subsection (b) of Section 12311 of the Govern-
3 ment Code is amended to read:

4 "(b) The use of the cast-net (talaya) is prohibited
5 from boat slips in the Agana Boat Basin. Within the channel
6 and mooring area, the talaya may be used only between the
7 hours of 4:00 a.m. and 8:00 a.m. Within the other areas of
8 the Agana Boat Basin, the talaya may be used at any time."

9 Section 2. There is appropriated from the Territorial
10 Lottery Fund to the Department of Agriculture the sum of Seventy-
11 Five Thousand Dollars (\$75,000) specifically for the purpose of
12 providing assistance through loans to non-profit organizations
13 involved in the marketing of fish and aquaculture products.

Section 3. The terms and conditions of any agreements executed under authority of Section 2 of this Act shall be as determined by the Director of the Department of Agriculture.

Section 4. The Administrative Adjudication Act shall not apply to the provisions of Sections 2 and 3 of this Act.
