


CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR

This is to certify that Bill No. 6, "An Act making an appropriation for various purposes," was on the 8th day of May 1981, duly and regularly passed.





AN ACT MAKING AN APPROPRIATION FOR VARIOUS  
PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. The separate sum of Two Hundred One Thousand  
3 Dollars (\$201,000) is appropriated from the General Fund and  
4 is apportioned for expenditure as follows:

5 (a) ~~Twenty-four and eight-hundred-seventy-six-thou-~~  
6 ~~sandths percent (24.876%)~~ <sup>z e r o (-0-</sup> ~~of the appropriation shall be~~  
7 transferred from the General Fund to the Legislative  
8 Operations Fund to be allocated to the minority for use in  
9 calendar year 1981.

10 (b) Nine and nine hundred fifty thousandths percent  
11 (9.950%) of the appropriation shall be transferred to the  
12 Department of Vocational Rehabilitation to use as the local  
13 share of costs of providing mass transit for the handicapped  
14 and elderly.

15 (c) Sixty five and one hundred seventy four thousandths  
16 percent (65.174%) of the appropriation shall be transferred  
17 to the Department of Vocational Rehabilitation for the  
18 sheltered workshop employees' salaries.

19 Section 2. The appropriation made in Section 1 of this Act  
20 shall be satisfied by the transfer of lapsed, unencumbered or  
21 unexpended appropriations from the General Fund made in Sections  
22 3 and 4 of Public Law 15-142.
