




CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR





AN ACT TO APPROPRIATE THE SUM OF FIFTY-THREE  
THOUSAND DOLLARS (\$53,000) TO THE DEPARTMENT  
OF PUBLIC WORKS FOR ELIMINATING FLOODING  
PROBLEMS.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from the General  
3 Fund the sum of Fifty-Three Thousand Dollars (\$53,000) to the  
4 Department of Public Works for the purpose of alleviating and/or  
5 for eliminating the flooding problems in the Marianas Terrace  
6 Subdivision in the municipality of Yigo.

7 Section 2. The Department of Public Works is hereby directed  
8 to identify all flooding problems and submit a comprehensive re-  
9 port no later than thirty (30) days after the enactment of this  
10 bill to the Legislature.

1           Section 3. The Director of the Bureau of Budget and Manage-  
2           ment Research is hereby directed to identify all capital improve-  
3           ment projects funded by the General Fund and completed with fund  
4           balances. This report shall be submitted to the Legislature not  
5           later than thirty (30) days after the enactment of this bill.
